On the 08 August 2025 Natural Resources Wales received a TEN report for Beach Road CSO Old Colwyn - CG0139401. This asset is currently at Stage 4 of the TBN process which NRW have agreed upon. The next update regarding this site is due in March 2026.

On the 29/11/2024 Natural Resources Wales received a TEN report for Beach Road CSO Old Colwyn - CG0139401.

Natural Resources Wales have noted the actions within the TEN report and DCWW are required to carry out the following actions as per the TEN report –

1. Complete and finalise the surface water inflow investigation – 31st May 2025
2. Issue and share report following completion of investigation – 30th July 2025
3. Commence agreed sampling programme to confirm surface water quality - 01st August 2025 – 20th December 2025
4. Present findings in a final report with outline proposal to divert identified surface water - 31st March 2026
5. Implement surface water removal project pending regulator and local authority agreement – 31st May 2026
