4. Details of our assessment

Notification of OSM Sample Exceedance – Llanefydd STW (CM0018701)

On 18 September 2025, Natural Resources Wales (NRW) received a notification from Dŵr Cymru Welsh Water (DCWW) regarding an exceedance identified in their Operator Self-Monitoring (OSM) sample at Llanefydd Sewage Treatment Works (STW), permit reference CM0018701.

The sample was collected on 10 September 2025 and recorded the following exceedance:

Biological Oxygen Demand (BOD): >155 mg/l

Permit Limit: 110 mg/l

This represents the first BOD exceedance at this site within the past 12 months.

It should be noted that this result is not classified as a permit failure, as it falls within the allowable number of exceedances based on the Look-up Table (LuT) and the site's sampling frequency.
