4. Details of our assessment

This CAR is in response to incident WIRS 2507058. I requested the data from this site for flow, storm tank levels and spills for around the time of the incident.

Cardiff West SPS went into spill for roughly 2.5 hours on the 31st of July between 16:00 and 18:30. The spill was said to have been caused by a valve failing to open, which caused a restriction in flow being passed forward by the pumps, the permitted overflow setting

being 1810l/s, however DCWW said only 940l/s was being pumped, with anything greater being sent to the storm tanks. Once the storm tanks filled the site discharged for 2.5 hours. DCWW said the watercourse was not inspected or sampled at the outfall due to unsafe access. A sample of the discharge should have been taken from the discharge monitoring point sampling location as per table S3.4 in the permit.

This Cardiff Western SPS site sits within the Cog Moors sewer catchment area and rainfall from the Cog Moors rain gauge shows minimal rainfall at the time of the incident on the 31st, due to this the spill was not during storm conditions.

For the spill to be classed as an emergency the permit states in table S1.1 *"mechanical breakdown of duty and standby pumps"* the pumps were still operational and not in a state of breakdown.

The receiving watercourse is to the lower Ely with a large dilution capacity, along with the effluent being mechanically screened, the impact to the watercourse was likely minimal. However since it was not during storm conditions, and a discharge sample not taken, the BOD and ammonia would have likely been elevated at the point of discharge and for a short distance downstream.
