4. Details of our assessment

Routine inspection of Asset. The weather conditions were dry and sunny at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BJ0091401) for the site is for the discharge of secondary treated sewage effluent to the Afon Teifi.

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers didn't check the discharge point to the Afon Teifi due to health and safety issues, but there did not appear to be any evidence of fungus in the final effluent sampling point.

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

Effluent enters the site at the inlet, before entering 2 primary tanks. The effluent then gets treated by 2 large filter beds. The filter beds had a lot of growth of vegetation however the arms were moving freely and there did not appear to be any issues with pooling. The effluent then enters into 2 final settlement tanks.

Permit breach

Condition 2.1 The only activity authorised by the permit is the activity specified in schedule 1 table S1.1; the discharge of secondary treated sewage effluent via the Final Effluent Discharge Point

There was sewage leaking out of the brickwork of the final settlement tank and pooling on the ground. It was discussed at the time of the inspection that the source of this leak needs investigation and repairing prevent further discharges to the ground.
