4. Details of our assessment

This report details the site visit made on the 2nd September 2025 to Bryn Aggregates Ltd, permit reference number EPR/DB3399CE. Natural Resources Wales (NRW) Officers Cerys PHILLIPS, Greg GARDNER and Nicola ROSSITER attended Bryn Recycling Limited site for an announced handover site inspection at 9:30am where we met with Ms. Jennifer PRICE (AD Plant Manager). The weather was rainy during the inspection following a prolonged dry period.

GENERAL OBSERVATIONS

Ms. PRICE escorted NRW Officers around the permitted site where quarry operations were taking place. There were no offensive odours and / or excessive noise witnessed by NRW Officers during the site inspection. There was no excessive dust(s) witnessed by NRW officer at the time of the inspection. Housekeeping standards on site were satisfactory with no issues raised. The site holds a water abstraction licence for quarry operations, with NRW, under permit reference: WA/057/0022/0005.
