4. Details of our assessment

Sample Exceedance Report

At 13:59 on 17th September 2025, Natural Resources Wales (NRW) Data Collection Officers took a water quality sample of the bike wash effluent at Beic Parcio Cymru (BPC) – permit BB3197FK. This was part of NRW's routine monitoring. The results of which are as follows:

Oil and Grease Visible:

Permitted limit – Not present

Result - Present

Suspended Solids:

Permitted limit of 10 mg/l.

Sample result of 49 mg/l

At 13:42 the same day a sample was taken from the monitoring point for permit AB3591CP. This is the PTP discharge point to the Nant Graig (SO 05057 03532) for BPC. The results for this sample were all within permitted limits - 27mg/l for suspended solids and no oil or grease visible. This is also the location where the bike wash discharges to the environment using the same pipework therefore any environmental impact would appear minimal.

Site History

These exceedances appear to be a continuation of problems with the permitted discharges at BPC throughout 2025. Over the last four months BPC have been attempting to find the root cause and rectify the poor effluent quality. Sample results have been intermittently failing.

As a result of the ongoing sample failures an anti-pollution works notice was issued to BPC on 01/10/25.

Requirements to update and implement an action plan along with increased monitoring are to be put in place.

Breaches of permit condition:

3.1 Emissions to water - 3.1.2 The limits given in schedule 3 shall not be exceeded. The samples show the following breaches of permit.

Oil and Grease : present - This is a Cat 3 breach of permit condition 3.1.2.

Suspended Solids: 49mg/l – This is a Cat 3 breach of permit condition 3.1.2.

Action required by dates specified:

Comply with the works/operations listed under Schedule 1 of Anti-Pollution Works Notice 15662.
