4. Details of our assessment

This compliance assessment report is being produced following a routine, announced inspection of North Powys Bulking Facility. The inspection was conducted by Luke Taylor (Senior Waste Regulation Officer) of Natural Resources Wales, and the site was operational at the time.

The weather was dry and overcast. The officer was accompanied by Nigel Hicks, Waste and Recycling Area Manager for Powys County Council, throughout the inspection.

W1A General Management

On attendance, the officer met with Nigel Hicks and conducted a review of the site file. Daily checks are being undertaken as required, including odour and dust management checks in line with the relevant plans. A copy of Mr Hicks' Technically Competent Management certificate was on display, detailing current continued competency qualifications.

W2A Permitted Activities

The waste transfer shed doors were closed, with waste being moved inside. Mr Hicks stated that there was slightly more recyclable waste at site currently due to maintenance of machinery at the Brecon site. This was being well managed, with all waste contained within the relevant bays.

Between the food waste bay and the rest of the transfer building floor area is a drain which was clear of any debris. It was evident that the bay had been washed down prior to the most recent deposit.

Outside the transfer building the glass waste was being stored correctly within the designated bay, as was the green waste, with the drain in front being clear.

W3C Odour

There was no odour detected outside of the permitted area of the site at the time of the inspection.

W4B Reporting

All waste returns have been submitted as required for the most recent quarter.

Other observations

The site does not currently accept residual waste, however this is soon to change. All of the infrastructure is in place, with the transfer building having been constructed to accommodate loading and tipping with the doors closed, to limit any potential impact. When the site does start to accept residual waste, please ensure that the odour management plan is reviewed and updated as necessary, and provide Natural Resources Wales with a copy of this for review.
