4. Details of our assessment

Limit Breach Notification – Tavern Caravan Site Treatment Works

On 4 March 2025, a routine sample collected by Natural Resources Wales (NRW) from the Tavern Caravan Site Treatment Works revealed an ammonia (NH₄) concentration of **33.4 mg/L**, significantly exceeding the permitted regulatory limit of **5 mg/L**.

This result represents a substantial breach and has been assessed as a **Category 2 environmental impact** (significant). However, it is important to acknowledge that the condition of the receiving watercourse has improved since the implementation of the new treatment system and permit. This positive change has been taken into account in the overall assessment.

Additionally, I recognise the delay in notifying you of this breach. In light of this, and considering the improvements observed, **any other breaches occurring between this incident and today's date (2 October 2025) will be waived.**

Action. Maintain treatment system in accordance with your written management plan, to ensure discharge limits achieved. I require a response with a plan of improvements before the 31/10/2025
