4. Details of our assessment

Compliance inspection undertaken by Environment Officer Harry Warburton of permit

AN0048001 at Windsor Espalande accompanied by DCWW performance manager and AGA pollution tech. Weather at the time was dry.

This site is covered by an old NRA permit and is fairly unknown to DCWW and NRW. During the inspection covers were lifted in the vicinity of the grid reference in the permit, and there appears to be an abandoned sewer here as the line had a large amount of rubble and was dry. DCWW were unaware of any activity from this permit, however BGA may have a bit more knowledge. It is also unmapped on our systems. The outfall for the site could not be observed due to being in Cardiff Bay wetlands.

Action

- More investigation will have to be taken by DCWW to confirm whether this sewer is still in use. If so the permit will require updating to the modern format to reflect current environmental permit regulations, however if it is no longer in use DCWW should decommission the network to ensure no discharge could be made and provide evidence of this, as well as surrender the permit.
