4. Details of our assessment

An OSM site inspection was carried out on the 17th September at Five Fords Wwtw by NRW and attended by DCWW representatives.

The treatment works looked to be in working order at the time of the visit and the final effluent was clear. There had been a period of heavy rain and was still raining while on site - the storm tanks were discharging at the time.

Storm tank discharge into the afon Clywedog:



2 treatment works in operation simultaneously - A (aeration) which takes 70% of the flow and F (filtration) which takes the remaining 30%. Both of which are dosed with ferric chloride for P removal.

Chanel diverting flows to A & F Works 70/30:



Tighter P limit from 2030, the site should meet new limits as it is now, but it is likely will need more controls will be needed to bring down the level a little more.

Recent Aluminium failure at the site, NRW are now awaiting for an ECR (exceptional circumstances report) for this result. It was explained that Aluminium was historically used within the treatment process, but hasn't been used now for a number of years. It was briefly discussed as to whether this should be removed from the permit if this is the case.

The site is trialling new aeration methods, due to the existing system being expensive and requiring frequent maintenance/replacement. Proposed favoured method 'aeration boats' - floating aeration equipment.

Aeration boats in operation:



Final tank No 3 has recently been off-line for scraper repair, syphon repair and centre column. OPNOTS were received for this work. An eye was kept on the weather during the period and could have been diverted back if the need arose. Similar work likely on another final tank next, OPNOT will be submitted for this work.

New concrete pad and associated bund has been installed for the sludge cake to contain any potentially contaminated drainage.

Concrete pad and bund level raised to ensure sufficient containment:



The site was highlighted as having potentially low FPF for 2024 and was discussed on site.

However, this seemed to be an issue with the data transferring between the 2 DCWW systems.
NRW will now request flow and spill data from Dwr Cymru for this site
