4. Details of our assessment

On Monday 22nd June 2024 Natural Resources Wales officers attended site.

This was a routine site inspection for permit ref EPR/FB3734RP which was carried out by Waste Regulation Officer Ian Thomas, accompanied by waste crime officer El.

On arrival at site, i met with Paul Dromgoole, one of the owners, the technical competent manager, Martin Womack was not on site.

We completed a walk around the permitted area of the site. As mentioned in the previous inspection, the site is undergoing improvement where storage will be increased and a one way road system implemented. I reminded Paul to ensure the treatment of waste materials was kept within the permit boundary.

I noted where waste is brought in via tipper vehicles, some of the inert waste being treated, and some 6F2 product stored.

The metal shown, is removed allowing the concrete to be treated. Prior to my visit waste returns were checked but showed that no waste had left the site in all the returns submitted for 2025.

This has been recorded as an **action:-** Please review waste returns to ensure any waste materials leaving site are accounted for and recorded appropriately.

Request – Please supply a selection of waste transfer notes to be checked for September 2025. Also, please supply copies of delivery notes for materials delivered to Mr Richard Rogers, Allt Gymbyd Farm, Llanarmon-yn-ial.
