4. Details of our assessment**LLANDDULAS LANDFILL - ENGINEERING (CAPPING) INSPECTION, CQA, WELD INTEGRITY AND GAS MANAGEMENT DURING CAPPING WORKS****02nd October 2025****10:00hrs**

A site meeting took place with the nominated CQA Engineer, Mike James of Sirius Group. We inspected several weld seams on main panels and extrusion welds around features and it was agreed that the welding and capping engineering was compliant with the required CQA standard.

Seam weld samples were provided for proof of integrity and samples for lab analysis have been taken in accordance with the CQA Plan and will be sent to the labs for final testing.

Final soils were being applied to the geotextile with works being graded behind completion of welding and geotextile in an East to West direction.

Areas where the gas collection system required disconnecting were inspected and all wells were capped/sealed adequately. Only mild background odour on site was detected, which is expected whilst the capping work is taking place.

Relevant permit conditions are highlighted in bold below.**1.7 Ongoing Engineering of Relevant structures**

This condition requires the production of a detailed design and construction CQA plan.

This plan was duly submitted to NRW in April 2024 in appropriate time for assessment and approval before the commencement of works. The plan was approved by NRW in April. Inspected aspects of the plan are being followed closely with appropriate testing taking place.

1.8 Regulatory Standards for the Construction of Caps, Waste Slopes, Surface Water Drainage Layers and Cover Soils

This condition requires that the capping is constructed in accordance with the submitted design and standards are referenced throughout to the CQA plan submitted as part of the engineering and design requirements as laid out in the permit. All aspects of the design and the build are subject to the oversight of a CQA engineer and the Engineering Team of the on-site contractors. All aspects of this process were in compliance with permit/design/CQA requirements on the day of inspection.
