A site audit on the 18/9/2019 found an excessive amount of sticks and leafs that had partially obstructed the HOF. this reduced the amount of water that should have been able to go down the fish pass> this will impact in fish migration going up stream.

Action more regular site visits by the permit owner to ensure that the Hands off flow and fish pass at clear.

It was identified in a desk top investigation that a similar report was made last visit, it has only not been escalated because the site is not generating power at the time of visit.
