4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine site inspection at Hafod Landfill.

Immediately before attending site, NRW officers completed offsite odour monitoring at the following locations:

- New Hall Road- slight landfill gas odour at the junction with Bangor Road. (3/6) A waste /sewage type odour was detected approximately half way up New Hall Road.
- Shellbrook Drive Ruabon- no odours
- Bedwell Drive – no odours
- East Avenue – no odours
- B5605 – no odours
- Vauxhall Industrial Estate- no odours
- Ruabon Road near Co-op - distinct silage and slurry odours (3/6)
- Top (west) Bangor Road- distinct silage and slurry odours (3/6)
- Tan y Clawdd, Y Fron, Gwalia, Worsley Avenue and Melyd Avenue – no odours
- Bangor Road near Hafod Landfill entrance- slight leachate odour (<1/3)
- Heol Kenyon - distinct silage and slurry odours (3/6)

The Regional Manager accompanied officers during the onsite inspection.

One of the gas engines has recently been replaced and was operational. Localised and intermittent landfill gas odours were detected near the gas engines (2/6). Further localised landfill gas odours were also detected near LC4 and the active tipping area (4/6).

The weather conditions preceding the site inspection included heavy rain and strong winds, and as a result there was evidence of windblown debris along the eastern boundary. The operator confirmed that provision was in place to "litter pick" in this area to minimise the risk of material migrating off-site.

The operator highlighted additional permanent capping had been installed along the eastern boundary at the edge of Cell 3, Cell 4 and Cell 5a. Proposals to install additional temporary capping at Cell 5b were also discussed.

Waste disposal operations continue to be carried out. The operator confirmed that once they reach final levels at Cell 5b they plan to commence tipping in Cell 5c which was being constructed at the time of the site inspection. The operator estimates that tipping in Cell 5c will commence in early 2026.

A new concrete haul road has been constructed on top of Cell 4 to aid vehicles tipping waste and minimise the generation and migration of mud.
