4. Details of our assessment

A routine site inspection was undertaken on Friday 3rd October 2025. Present at the time of the inspection were: David Morgan (Natural Resources Wales) and Gavin Griffiths (Director, Griffiths Waste Management Ltd).

The inspection undertaken on Friday 3rd October 2025 was the first inspection since the Environmental Permit had been transferred to Griffiths Waste Management Ltd from the previous holder, South West Wood Products (transfer completed 6th November 2024).

On Friday 3rd October 2025, the following observations were made:

Site Infrastructure & Operations

It is noted that following the transfer of the Environmental Permit last year, the site remains in a state of transition. Major infrastructure works are taking place which includes resurfacing of areas where waste will be stored and treated.

Improvements made to site surfaces appear to have alleviated issues with drainage and there is little to no standing water, which has been an issue on site in previous years. Also, the site surface now appears to be maintained to a level that would allow greater access for plant, equipment and emergency vehicles in the event of an incident.

Waste Storage

Currently, large volumes of inert materials are stored on site. The majority of this waste (soils, earth, stone) has been generated from the resurfacing works. The intention is to treat (crush/blend) this material and remove it from site.

At the time of the inspection, wood waste was being stored on site in two separate stacks. Although major infrastructure works are ongoing, please ensure this wood waste is stored in stacks that comply with the parameters of the site Fire Prevention and Mitigation Plan (FPMP). From an initial visual inspection, both stacks, at the time of inspection, appeared to be well within the limits stated in FPMP guidance (height, width).

Environment Management System & Fire Prevention and Mitigation Plan

Following the transfer of the Environmental Permit, and change of Operator, please submit to Natural Resources Wales, up to date copies of the Environment Management System (EMS) and Fire Prevention and Mitigation Plan.

Dust Management

Owing to the large volume of inert material now stored on site, it is likely, that in a future inspection we will request further information and possibly a demonstration of dust management measures.

At the time of the inspection, there were no signs of dust escaping site and there were no visible deposits of dust/earth/mud at the entrance of the site. The areas around the entrance of the site appeared to be well maintained.

No non-compliances with the Environmental Permit were recorded during the inspection.
