4. Details of our assessment

A site inspection was undertaken on Friday 3rd October 2025. On this date operations were assessed as being compliant with the Environmental Permit.

The following observations were made:

Site Infrastructure & Drainage

It was noted that the site is undergoing infrastructure works, most notably the installation of a new impermeable, concrete pad. It is expected that in coming months, the layout of operations on site will change.

Please ensure changes to operations (including site layout) are reflected in an updated Environment Management System (EMS) and Fire Prevention and Mitigation Plan (FPMP).

In a previous inspection, an issue with site drainage was identified as small volumes of site surface water were escaping site (far left corner of site upon entering). This had not caused a pollution in the past although site surface water should be contained on site. This issue is now resolved and no site surface water was escaping site.

Waste Storage

All waste on site appeared to conform with the list of acceptable wastes in the Environmental Permit. Waste stored in the building was stored in a manner that is compliant with Fire Prevention and Mitigation Plan guidance.

A skip of plasterboard was being temporarily stored outside while changes to waste storage were being made. This skip was placed back inside the building upon request (to prevent rainwater ingress).

Emissions (Dust)

At the time of the inspection, areas at the entrance of the site and access roads to the site appeared to be well maintained. There were no signs of dust escaping site and the access road to the site was free from any mud/debris which suggests there are no deposits of waste (earth/soil) from vehicles and/or any deposits on the road are cleared.

No non-compliances were recorded against the Environmental Permit.
