Site Report

Environment Officer Peter Jones carried out a routine site inspection on the site on 2 October 2025 and met with site manager and Area Manager.

The inspection involved a visual review of the site infrastructure and drainage and a review of documents required under the permit conditions. Overall the site infrastructure was found to be in reasonable condition. However, there are some areas where the existing concrete surface needs to be replaced. Please ensure these areas are repaired within a reasonable time frame to ensure there is no risk of pollution to surface or ground water.

Overall, the site was clean and tidy and there were no reports of noise or odour complaints.

Following the site inspection, the officer proceeded to the site office to inspect documents required under the permit conditions, these were all in order and available for inspection.

Carcases are currently removed by Celtic Baits and waste transfer notes are all in order. The carcase store was locked and secure.

Waste water generated down wash down operations is removed from site by Mayglothing Ltd and the transfer notes were all in order.

Poultry manure is exported from the site by Gamber Poultry Litter, the last three loads were transported to Rose Dew Farm Llantwit Major. Manure is removed immediately from site when the sheds are emptied of stock. Therefore, there is no requirement on site for manure storage facilities.

There were no issues found with the management plans or incident procedures.
