4. Details of our assessment

On the 2nd September 2025 a Sampling Officer from Natural Resources Wales attended The Black Cock Inn, Waunwaelod Way, Caerphilly, CF83 1NF to undertake final effluent

discharge samples on the Sewage Treatment Plant. Permit Number WQD009196. Sample results confirmed on the 4th September 2025.

Breaches of permit condition:

1.6 Composition- As far as is reasonably practicable, the sewage treatment plant shall be operated so as to prevent the Discharge from containing any visible oil or grease.

Justification:

Oil and grease was visible in the sample.

Actions required by date specified

1.) Identify cause of oil and grease and improve operation of the plant to prevent presence in future samples
