3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

During a routine compliance assessment check that we have carried out on 9th October 2025 it was noted that the EDM operational time for this asset was less than the minimum of 90%.

Note: EDM operational time data was originally submitted to NRW in February 2025. DCWW then resubmitted the data with corrections in May 2025. This assessment has therefore been made using the resubmitted data.

The operational time provided in the 2024 EDM Annual return for CM0208701 - Gwyddelwern pumping station was 6.95%.

Condition 3.1.4 states that "The operator shall take appropriate measures to ensure that the event recorder remains fully operational at all times within the reference period specified in table S3.1. Any failures shall be remedied as soon as reasonably practicable".

This site was also non-compliant for this condition in 2023.

Guidance for scoring the non-operational time suggests that this may have had a category 2 impact: when the EDM is operational for 0-10% of the calendar year. The lack of data makes it unlikely that the operator can confidently assess the performance of the asset. It also suggests that the overflow is receiving inadequate, or no monitoring and that the operator has not resolved operational issues in a timely manner.

Actions – please carry out the actions specified above to comply with permit condition

The data submitted was initially made within the required deadline as specified by the permit (28 February 2025). The data was then resubmitted after the deadline. The resubmission was made because the original data was erroneous. This resulted in condition 4.2.2 (b) being breached as the correct data was not submitted within the deadline. The permit holder had been operating the asset whilst using erroneous data relating to discharges. This had the potential to result in discharges being made without a system which minimised pollution. This has the potential to lead to significant impacts on the environment and is a breach of permit condition 1.1.1.
