4. Details of our assessment

This compliance assessment report is being produced following an unannounced inspection by Luke Taylor (Senior Waste Regulation Officer) of Natural Resources Wales.

The weather at the time was dry and overcast. There was no activity ongoing at the site.

The following non compliance has been identified:

W1A General Management - Permit Condition 1.1.4 - Category 3

You have been scored for the above breach as, during a check of the Technically Competent Management provision for your site, it has been identified that the continued competency for Mr Pryce is lacking any activity specific qualifications, only the standard generic knowledge assessment module has been completed. This has been the case since at least 2020 from review of the CIWM / WAMITAB records.

Your permit states that the operator shall comply with the requirements of an approved competence scheme. You must ensure that the activity specific module is completed relevant to your permitted activities for any continued competency qualification to be valid.

ACTION - Obtain the relevant continued competency qualification for the permitted activity. Deadline 30/11/2025

W4B Reporting - Permit Condition 4.2.2 - Category 3

You have been scored for the above breach as no waste returns have been submitted to Natural Resources Wales since quarter 1 of 2022.

Your permit states that within one month of the end of each quarter, the operator shall submit to Natural Resources Wales, using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

You must ensure that waste returns are submitted for the outstanding periods, even if no waste was accepted or removed. Returns are required for Q2, Q3 and Q4 of 2022 and for all quarters of 2023, 2024, along with Q1 and Q2 of 2025. Q3 of 2025 will be required by the end of October.

ACTION - Submit all outstanding waste returns to NRW. Deadline 30/11/2025
