3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

On the 17th July 2025 a Sampling Officer from Natural Resources Wales attended Los Reyes Tapas, Belmont Hill, Caerleon, Newport NP18 1JX to undertake final effluent discharge samples on the Package Treatment Sewage Works. Permit Number AN0291801. Sample results confirmed on the 30th July 2025.

Breaches of permit condition:

Composition

6. The Discharge shall not contain more than:

(ii) 10 milligrams per litre of suspended solids (measured after drying at 105 C)

Justification

A sample was taken on the 17/07/2025 as part of routine monitoring. Sample results confirm that the suspended solids (measured after drying at 105 C was 162 milligrams per litre. The maximum Parameter limit is 10 milligrams per litre. This is a breach of 152 milligrams per litre.

(i) 6 milligrams per litre of biochemical oxygen demand (measured after 5 days at 20 C with nitrification suppressed by the addition of allyl-thiourea);

Justification

A sample was taken on the 17/07/2025 as part of routine monitoring. Sample results confirm that the biochemical oxygen demand (measured after 5 days at 20 C with nitrification suppressed by the addition of allyl-thiourea); was 24 milligrams per litre. The maximum Parameter limit is 6 milligrams per litre. This is a breach of 18 milligrams per litre.

Actions required by date specified:

- Inspect Package Treatment Sewage Works.
- Identify the reason for the sample failure.

The above action is required by the 10th November 2025.
