4. Details of our assessment

National Grid Electricity Distribution (EPR/AB3398FZ) – 22/09/2025

Waste Regulation Officer Daniel Hopkin and Marc Campbell attended the permitted facility of National Grid Electricity Distribution at Duffryn Bach Terrace, Church Village, Pontypridd, CF38 1BN on the 22nd of September 2025 to undertake an unannounced routine site inspection.

National Grid Electricity Distribution Bridgend hold a Standard Rules 2012 No15, Storage of electrical insulating oils permit for this site. We arrived at 10:40. The weather was dry with sun.

Infrastructure and Storage

The site infrastructure was in good condition throughout, with no signs of damage to the impermeable surface or drainage. The site had good security measures in place, with cameras and electric gates.

All waste oils were stored on an impermeable surface in a bunded area in accordance with permit condition 2.3.1. There were spill kits available on site.

Environmental Management System (EMS)

A copy of the updated Environmental Management System (EMS) was available on site to see in line with permit condition 1.1.1(a).

Site Competency

On the last inspection of this site, you had a Technically Competent Manager under the CIWM (WAMITAB) scheme. It has been noted that this has now changed to an EU Skills competency scheme which demonstrates technical competency to manage and comply with your environmental permit. This is in compliance with permit condition 1.1.4.
