4. Details of our assessment

On 13 October 2025 the Operations Team at NRW were notified of the passing of the Operator Mr Huw R Edwards.

As the operator has passed away and the time frame for transferring the permit has already passed, the permit will be lapsed. This report has been compiled as a final record of the risk the landfill poses on the surrounding environment.

The Saltings (West Usk) Landfill, permit number EPR/CP3399FY (formerly EAWML 30028), was originally permitted in 1989 under the COPA provisions to accept inert waste.

The site was licensed to accept inert wastes: building rubble, rock, sand, topsoil, subsoil and from 1994 - foundry sand/slag mix.

Aerial Photographs of the site, approximate location outlined in red, shows no waste activity being undertaken, and vegetation is well established.





Compliance History

Site Inspection records taken at the time indicate that there were some issues with permissions and overtipping at the landfill in the past. However, documentation also shows that during a site inspection of 27 November 2002 that most of the waste at the landfill site had been removed, although some residual waste remained.

A more recent Compliance Assessment Report (CAR) number CAR_NRW0034943 from 08/04/2019 stated that in the late 90's the site was almost completely remediated by the Environment Agency to build a sea wall.

Monitoring

Following the removal of the majority of the waste, the CAR from 2019 also confirmed that there was no requirement to submit monitoring results, and no further monitoring would be required. It is likely that the permit would have benefitted from a low risk surrender.

Conclusion

It is concluded from the information gathered on the site, that the risk this landfill continues to pose to the environment is likely to be low.
