4. Details of our assessment

LLANDDULAS SITE PERIMETER - ROUTINE INSPECTION FOR ODOUR

NRW undertook a routine perimeter site odour inspection Of Llanddulas Landfill on the 09th. October 2025 at approximately 10:45hrs. This covered a full perimeter odour inspection in areas where historic issues have been detected.

During the final capping procedure some gas infrastructure has been switched off for engineering purposes. All pipe-work was adequately sealed during this disconnected phase and the gas system balanced accordingly.

No odours were detected during this inspection.

The site is being responsibly managed and is compliant for emissions to air and odours beyond the site boundary but will still be subject to occasional odour inspections in the absence of complaints/incidents.

The permit conditions relating to odour compliance for the landfill site are reproduced below:

3. Emissions and monitoring

3.1 Emissions to water, air or land

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 4 tables S4.2, S4.3 and S4.4.

3.4 Odour

3.4.1 Emissions from the activities shall be free from odour at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency,(NRW), unless the operator has used appropriate measures to prevent or where that is not practicable to minimise the odour.

On this occasion there were no breaches of these conditions. Please ensure that site continues to comply with permit conditions and follow all agreed procedures in the GMP/Site EMS.
