4. Details of our assessment

This report details the site visit made on the 30th of September 2025 to Volehurst Limited, permit reference number EPR-KP3595FB. Natural Resources Wales (NRW) Officers Carla CURTIS and Cerys PHILLIPS attended the permitted facility at Old Esso Depot, Newport for a routine unannounced site inspection. Officers arrived at 11.30 am. The site was operational at the time of the site inspection. The weather was sunny and warm.

PERMIT BREACHES

No permit breaches were identified during this site inspection.

SITE INFRASTRUCTURE

The site operates on a concrete hard standing which appeared to be in good condition with no damage as can be seen below in photo 1.

The site benefits from an interceptor system which is then discharged with consent to Welsh water foul lines.

OPERATIONS ON SITE

Waste arriving onto site is hand sorted by staff.

General housekeeping on site was of a good standard. Please ensure that daily checks are made to keep litter around the site to a minimum, in order to avoid any escaping the confines of the site. The height of waste stockpiles on site were compliant with the requirements of the permit and no issues were identified.

There was no excessive noise along with no airborne dust present during the site inspection. There were also no offensive odours witnessed by NRW Officers on site and security was of no concern.
