4. Details of our assessment

The Operator submitted a proposal to implement a minor operational change which will include the utilisation of the existing ash barn storage area for the temporary daily storage of waste.

The purpose of the proposed change is to improve efficiency by minimising the queuing time for HGVs to tip.

The proposal, dated August 2025, was reviewed and is agreed by NRW, and summarised as follows:

- Low volume municipal waste, delivered by small, caged vehicles, is to be temporarily stored in the ash barn for no more than 12 hours before being transferred to the main tipping hall.
- The waste will be stored in the ash barn during tipping hours and transferred at the end of each working day. Waste will not be stored in the ash barn overnight.
- The proposed operational change does not introduce any new waste types, exceed permitted tonnages, or alter the site's overall environmental risk profile.
- The proposed changes have been reviewed against the site's existing Traffic Management Plan, Fire Prevention Plan, Risk Assessments, and Environmental Management Plan to ensure no new or increased risks to health, safety, or the environment.
- All changes will be incorporated into the site's Environmental Management System, Fire Prevention Plan, and Traffic Management Plan.

NRW regulating officers will review the process and associated procedures during their next planned inspection.
