3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

A routine site inspection was undertaken on Thursday 9th October 2025. Present at the time of the inspection were: David Morgan (Natural Resources Wales) and Andrew Thomas (Site Manager, Green Metal Salvage).

An inspection was undertaken and the following observations were made:

Waste Acceptance

The Environmental Permit for the site allows for end-of-life vehicle storage, depollution and dismantling. It is noted that in the yard, a T9 Waste Exemption is registered and the site accepts significant volumes of scrap metal.

At the time of the inspection, mixed waste skips were being stored on site. This waste is not permitted and these skips must be removed with waste being taken to an appropriate authorised facility.

Mixed waste skips are not permitted on site. There was no significant environmental impact and this non-compliance has been recorded as minor in nature.

A non-compliance was recorded against Condition 2.2.1 of the Environmental Permit (Category 3 - Minor) (Ref:W2E)

Environment Management System

Following an inspection of the yard, Natural Resources Wales requested copies of the site Environment Management System (EMS) and Fire Prevention and Mitigation Plan (FPMP).

These documents could not be located when requested on site.

A non-compliance has been recorded against Condition 1.1.3 of the Environmental Permit (Category 3 - Minor) (Ref:W1A)

You must ensure copies of the EMS and FPMP are up to date and are readily available on site for all staff who have responsibilities under the Environmental Permit.
