4. Details of our assessment

This inspection of the Afan WWTW Final Effluent was undertaken as part of our 2025 pre-Bathing Waters season compliance programme.

Permit version in effect - 26/03/2021

This inspection was undertaken in conjunction with inspections for all permits at Afan WWTW (BP0284701, BP0287601 & BP0287701 also for the overflow, EO and screening at Abbey SPS). Other relevant CAR References are - CAR_NRW0048516, CAR_NRW0048517 & CAR_NRW0048518.

The weather was dry at the time of inspection following a period of prolonged dry weather, the works appeared to operating well, as designed. No new non compliances were noted. The following action should also be completed;

Action

Provide information on any interplay between the AAD site and the WWTW, specifically relating to the transfer of liquors from the AAD process to the WWTW. Confirm if the the two systems are entirely separate or if there is any connection.

Conversations on site also confirmed that the team were hopeful for investment in grit treatment and funding for refurbishment of the one remaining SBR yet to be improved. NRW would welcome this investment and support investment of this type in the site.
