This was a routine data review of waste returns undertaken by Malcolm Dines (Waste Regulation Officer).

Permit Breaches

W4B - Reporting - Cat 3; Permit Conditions 4.2.2

You have been given this category 3 breach of the above permit condition because you have not submitted waste returns since the end of 2015.

You were reminded of this requirement by an action on compliance report CAR_NRW0039878, dated 6 May 2022. When I met you on 16 January 2024 for a compliance visit, you were not reminded of the requirement to submit waste returns and you were not scored on the subsequent compliance report (ref: CAR_NRW0043885, dated 28 March 2024), as it was anticipated that you would be submitting an application to surrender your permit.

As you have not submitted such an application, you must submit waste returns as required by this permit condition. Even if no waste is accepted at your site in a quarter, a nil return is still required to be submitted to Natural Resources Wales.

Action: Submit all outstanding quarterly waste returns, or at a minimum, for the past six years **by 31 December 2025**

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) Order 2012

Important information

Legal status of this report
