#### 4. Details of our assessment

### **SITE INSPECTION - GENERAL MANAGEMENT, PEST CONTROL AND FEEDSTOCK CONTAINMENT**

**16<sup>th</sup> October 2025**

An pre-arranged site inspection was undertaken on the above date at approximately 10:45hrs. to ascertain the efficacy of recent pest (bird) control measures on site, in response to a report of issues with crows and pigeons in increased numbers. The issue is the increased bird strike potential at nearby RAF Mona.

The site is currently filling clamps with feedstock hence the increase in potential for bird numbers to rise on site.

Site was very responsive and had installed a gas gun as a bird scaring device. Furthermore site have agreed to finish all filling of clamps by the evening of Friday the 17<sup>th</sup> October and re-instate the netting and covers over the storage clamps, which have been temporarily removed for logistic purposes.

There were very few birds on site during the inspection and It was found that all of the agreed protocols are in place. Therefore the site was compliant with permit conditions at this time.

The operator has agreed to explore further mechanisms to improve the 'feeding face' cover of the clamps during routine daily feeding and other operations.

The EMS covers the management and cleaning protocols for feedstock on site and this must be followed as a minimum to maintain control and avoid any potential future incidents.
