4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Edward Davies of Natural Resources Wales, accompanied on site by permit operator.

Purpose of the inspection was to assess current storage practices on site due to concerns raised and to assess previous actions that were placed on the site during the previous inspection completed on 7th August 2025, detailed in **CAR_NRW0049080**.

General Management - W1A

During the inspection, the waste on site was stored in 3 distinct stockpiles, on impermeable surface with fire breaks in place as described in the submitted Environmental Management System (EMS). The fire breaks installed remained in place, and were sufficient distance.

Netting at the rear of the site has now been installed, as required following the previous inspection as a requirement under the site's current EMS.

Waste Operations - W2A, W2C, W2D and W2E

During the inspection, it was noted that stockpiles of wastes remained high, due to some unforeseen external circumstances resulting in a reduction in the ability for the wastes on site to be removed.

As discussed on site, it is important that the operations have adequate contingency plans in place to ensure that waste operations on site remain compliant with the permit conditions and do not pose a threat to the environment or human receptors.

Wastes were stored in accordance with the EMS and permit, with wastes that were previously identified behind the storage bays now removed.
