3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

On the 07th October 2025 NRW Environment Officers met with Dwr Cymru members of staff at Ynysgarwed Sewage Treatment Works to conduct a site inspection audit.

This treatment works is visited on a monthly basis by a DCWW operative.

Observations and Actions

Upon inspection it was noticed that there was a broken fence, caused by a fallen tree. This could cause a public safety issue or for DCWW staff members. There was an additional fallen tree which was obstructing the pathway within the works.

There was a lack of grounds maintenance at the works in general as well as the sludge drying beds. Tree debris and leaf mulch was present on the percolating filter bed.

Action 1 - General maintenance and housekeeping, ensuring leaves and debris are cleared.

Leaking brickwork was observed in areas of the works which are referenced in the photographs below:



Action 2 - Remediate leaking brickwork.

It was noted that the sludge drying beds are never emptied and also in very close proximity to the canal.

Action 3 - Please explain the reasoning why they are not emptied and what is done to prevent any contaminated water from entering the canal.

it was unclear where the discharge point was from the works.

Action 4 - Dye trace to prove where the discharge point is. NRW suspect that it is the Afon Nedd, however would like confirmation from DCWW.
