4. Details of our assessment

The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer following up on outstanding actions re-issued after a pre-arranged installation visit on 06th August 2025. Those actions were:

1. CAR Reference NRW0044424 (issued 29/05/2024) - Action 1. Develop an Emergency Contingency Plan for the management of sludge and effluent and submit to NRW by 31 December 2024.

This was discussed verbally with the SHE Manager during the visit who indicated he had sent the plan to NRW. A search of our records shows we have not received such a plan. The AD plant involved has spare capacity should the site require it and can visit on a call out basis, again if required by the site. If this facility is unavailable, the site would cease operations until resolved. We require proof that such a plan exists by a confirmatory email or submission of the plan itself.

An email was received by the regulating officer from the site Safety, Health and Environment (SHE) Manager on 22/10/25. This contained various attachments, including an email from GP Biotec Ltd stating their Anaerobic Digestion (AD) plant had spare capacity/storage and would attend the site if a serious incident involving the effluent treatment process occurred.

In addition, a copy of Pilgrim's Environmental Accident Management Plan was attached, with page 8 stating the actions to be taken in the event of a failure of the effluent treatment process. One of those actions includes contacting GP Biotec Ltd to tanker away the effluent to their AD site.

2. CAR Reference NRW0044424 (issued 29/05/2024) - Action 2: Update PMP to include annual drainage inspections by a suitable contractor and submit to NRW for review by 31 December 2024.

The SHE Manager spoke about a new contract being set up to facilitate the drainage inspections. NRW would need to check the Preventative Maintenance Plan (PMP)/maintenance programme for this once available.

The email also contained a copy of a current contract with Metro Rod to provide the following services to the site:

- Planned Preventative Maintenance (PPM) visits
- Attendance within 12 hours of first notification
- 24/7 emergency call out service

- Detailed site and service reports for operator records

I am satisfied that the actions mentioned above have now been addressed and can be closed. The email and attachments are on file.
