This inspection was undertaken as part of our compliance program

Permit version in effect - 25 September 2024

Inlet Works and Screens

Screens were noted to be operational and no issues noted. The grit removal system was offline and we discussed the need for OPNOTs as we had not received one for this. Our view on this is because it forms part of the normal treatment arrangement on site an OPNOT should be sent to NRW. That being said, from our discussion on site this would not be the case with your criteria for OPNOT requirement.

ACTION - Please share the DCWW document or procedure which details when an OPNOT is required to be sent to NRW. This can then be compared with NRW's requirements. **DUE - 16 February 2026**

Flow was not carrying over the storm weir to the storm tanks at the time of our inspection

Storm Tanks

The storm tanks were empty at the time of our inspection. However, it was noted that the area between the storm tanks and the inlet works had been flooded and this was clearly contaminated contained sewage.



An action had been placed on DCWW as per CAR_NRW0045250 to investigate and remedy the situation. NRW was informed this was actioned and resolved via the installation of a non-return valve.

Discussions on site now indicate the non-return valve has either not worked or is now stuck open allowing the flooding of the area with storm sewage.

NON COMPLIANCE - 2.3.2 (c) - *On-line storm storage must be fully utilised before a discharge occurs. It shall only fill with the excess flows due to rainfall and/or snow melt. The storage shall be emptied and its contents returned to the continuation flow as soon as reasonably practicable. The minimum on-line storm storage required is specified in table S3.3.*

ACTION - Please fix and/or improve the flap valve to prevent this from occurring in the future. **DUE - 16 February 2026**
