Morlais poultry unit was visited on 26th August 2025.

The site has been fallow since March 2025 and undergone a massive improvement in site infrastructure. It was good to see the cracks in the yard concrete, and drainage pipes have been addressed and repaired since the previous inspection. Site admin was also improved, with no non-compliances found.

Please see the only action, which is to provide NRW with an updated drainage plan for the site following the renovations.
