4. Details of our assessment

This Compliance Assessment Report is being produced following a routine, announced inspection of LAS Recycling by Luke Taylor (Senior Waste Regulation Officer) of Natural Resources Wales.

The weather at the time of the inspection was dry and overcast and the site was operational.

The officer was accompanied throughout by site staff.

W1A General Management

Prior to conducting the inspection, a review of the Technically Competent Management provision for the site was carried out. The continued competency qualification for Mark Saunders is valid until 6th December 2025.

The household waste recycling area was inspected first, with all wastes within the designated skips and containers. Each waste stream is labelled to assist householders and staff were managing activity well.

Following this the waste transfer section was inspected. All wastes were being stored correctly, with no evidence of any mixing of wastes. The picking line was in operation at the time of the inspection, with recyclables being segregated into separate streams.

W3G Fire - Permit Condition 4.7.1 - Action Only

The current version of the Fire Prevention and Mitigation Plan (FPMP) for the site was reviewed during the last inspection and deemed compliant. Since the last inspection, a new version of document 'LAS005 - Working Plan Appendix B - Accepted Wastes' has been submitted. Whilst it is understood that none of these additional waste streams have been accepted yet, when this does commence, please update the FPMP to reflect this change and provide a copy to Natural Resources Wales for review.

During the inspection of the waste transfer station area of the site it was found that one of the fire wall sections between the plastics bay and the adjacent bay had failed, with the surface damaged. As a result, this will no longer conform to manufacturers specification to be compliant as a fire measure. From discussion on site, there are a number of spare sections available in storage that can be used to replace the damaged section.

ACTION - Replace the damaged section of fire wall. Deadline 30/11/2025

W3C Odour

During the inspection there was no odour detected off site during a walk of the perimeter.

W4B Reporting

All waste returns have been submitted to Natural Resources Wales as required.
