Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

CARS form generated following data audit on Mynytho wastewater treatment works.

The site is permitted (CG0030801) to discharge to storm tanks and off-site to an unnamed stream that leads to the Afon Soch when the flow to treatment exceeds 3.77 litres per second. Flow data supplied is Flow Passed Forward and assumed to be collected from a meter after the weir that feeds the storm tank. As the site has EDMS data, two clauses of the permit can be assessed. This assessment has a focus on the dataset for the period of (04/10/2023 – 04/10/2024).

Analysing the data it indicates that the works is frequently treating more than the minimum required amount and that the site appears compliant most of the time with the storm overflow weir setting for flow. EDM (Event Duration Monitor).

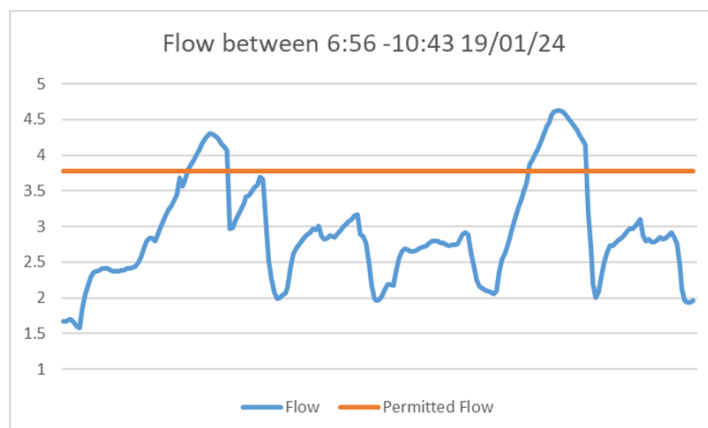
Further analysis of the data showed that there where spills to the environment but these only occurred when the flow passed forward was above the permitted rate.

On Average the site has overtreated by 27,864,019 litres, however when looking at the timestamps for when the site is below the FPF it is in breach for 11% of the year. Please see the graph below which highlights an example on the 19/01/24 between 6:56 and 10:43 when flow is consistently below the permitted rate.

The site did spill to the storm tanks when flow was below the the permitted flow of 3.77 letres/sec.

Action - What Investment is planned at this site to ensure that Mynytho Waste Water Treatment works is compliant with the permit and does not direct flow to the storm tanks when flow is below the permitted rate of 3.77 litres/sec. Please respond to this action by **01/08/25**

Please ensure that permitted flow of at least 3.77 litres/sec is treated at all times when flow is directed to the Storm Tank.
