4. Details of our assessment

On 16.09.2025 NRW received a report of discolouration to the Taf Fechan alongside unusual river level rises picked up on NRW telemetry next to Pontsticill WTW. At the time the reservoir spillway was not in operation.

On 18.09.2025 an OPNOT was submitted by DCWW confirming a water discharge activity under this permit. This activity was caused by elevated turbidity in recirculated process water resulting in the water being unsuitable and therefore unsafe to distribute. The reason for the elevated turbidity was a build up of sediment/sludge in the treatment process.

The discharge started on 14/09/2025 at 01:55 and the OPNOT submitted on 18/09/2025 at 11:07.

The permit states in condition 8 (c) and 9 (b) that DCWW will notify the agency as soon as reasonably practicable when there is potential for operation of the emergency overflow, or an emergency overflow has taken place. On this occasion the OPNOT was submitted just over 4 days after the discharge started.
