4. Details of our assessment

A sample taken at Rosemarket WWTW on 11/07/2025 returned a Suspended Solids result of 41 mg/l against a permit limit of 32 mg/l LuT.

This is the 1st exceedance for Suspended Solids at this site within the last 12-month period.

Update received from DCWW 29 October 2025

The exceedance was caused by the installation of an oversized replacement recirculation

(recirc) pump. The original pump had failed and, due to the absence of a specification for the unit that was removed, a larger pump was fitted reactively. This delivered excessive flow through the system, causing a flush effect that disturbed settled solids and led to poor settlement in the humus tank. As a result, solids were carried over into the final effluent (FE) sample point. Further investigation identified that the high flow from the oversized pump flooded the primary settlement tank (PST), requiring the pump to be throttled back. As the pump was throttled back, it triggered backflow that disturbed settled solids even further. A Five Whys analysis confirmed that the root cause was the reactive installation of an incorrectly sized pump, which led to poor settlement and solids carryover.

The oversized pump has now been replaced with a correctly sized unit. We are reviewing the feasibility of installing a solids monitor in the FE chamber to improve early detection and monitoring. A review is also underway to assess whether a smaller recirc pump can be added to telemetry. The new critical parameter board has been installed as part of the corrective actions.
