**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been raised following a submission of the revised Fire Prevention and Mitigation Plan (FPMP) that was submitted on 24<sup>th</sup> September 2025 and a review of Q1 and Q2 2025 waste returns.

The FPMP has been reviewed following recommendations detailed in CAR\_NRW0042901, a fire that occurred in the bio-drying tunnels and the addition of further detection and suppression equipment.

All recommendations have been implemented within the FPMP (IMS-FRM-046. Rev.7) that were highlighted in CAR\_NRW0042901. The bio-drying tunnels now have 10 pipework holes in each tunnel which allows for suppression to be delivered across the roofs of all the tunnels. 3 extra thermocouple points have been installed on each tunnel to further enhance fire detection in these areas. The extra measures have all been included in the updated FPMP.

The FPMP was reviewed by North Wales Fire and Rescue Service (NWFRS) and commented as below;

*FCC have invested significantly following an incident, the drying tunnel areas now have a much improved water feed and sprinkler suppression system due to extended pipework and more heads, it is envisaged this will assist in minimising the impact of a fire incident in this area and it will assist NWFRS getting water onto this otherwise potentially difficult to access area.*

*Due to the improvement works, any fire should require a lower attendance from NWFRS for a shorter time so this is viewed as a positive step.*

**Waste Returns**

Condition 4.2.2 requires that waste returns for the previous quarter shall be submitted within one month of the end of the quarter. Waste returns were submitted for Q1 and Q2 in 2025. The waste returns were reviewed and no issues were identified.
