4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter *NRW*) assessment against ALUK-GB Chepstow Aluminium Treatment Plant BB3790FX's Q2 Apr-Jun 2025 monitoring and reporting requirements. NRW's assessment of ALUK-GB Chepstow Aluminium Treatment Plant monitoring returns data is outside the scope of this CAR and any non-compliance arising from an exceedance of a permitted emission limit will be recorded in a separate CAR.

Condition 4.2.3 of the environmental permit states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- (a) in respect of the parameters and emission points specified in Schedule 4 Table S4.1;*
- (b) for the reporting periods specified in Schedule 4 Table S4.1 and using the forms specified in Schedule 4 Table S4.4; and*
- (c) giving the information from such results and assessments as may be required by the forms specified in those tables.*
