4. Details of our assessment

A routine site inspection was undertaken on Thursday 16th October 2025. This was the first inspection of the site since the Environmental Permit (ref: EPR/DB3498HD) was issued on 25th April 2025.

Present at the time of the inspection were David Morgan (Natural Resources Wales) and Ryan Moulton (Site Manager, Jayplas).

Permitted Activities

It is noted that waste acceptance and treatment activities have not yet commenced on site. Infrastructure improvements are currently ongoing to prepare the site for permitted activities.

During the inspection, an overview of planned infrastructure works and future waste operations was provided. Following completion of infrastructure works, the site will accept, store and treat (granulate/pelletise) plastic waste as listed in the Environmental Permit.

We discussed the drainage infrastructure and requirements under the permit. The permit requires all waste to be stored and treated on areas of the site that have an impermeable surface and sealed drainage system.

The drainage system, which will include a Full Retention Interceptor, will discharge to surface water (marked as discharge point SW-1).

Please ensure the drainage system is maintained and all chambers can be accessed for inspection by Natural Resources Wales at all times.

General Management

Following an inspection of the site, we discussed other aspects of the permitted operation. We discussed the requirement to work in accordance with a written Environment Management System. Please ensure copies of the Environment Management System and Environmental Permit are available on site.

Other items discussed included (in line with NRW 'First Inspection Checklist', available on Document Management System): Technical competence requirements, Duty of Care (Waste Transfer Notes), Waste Returns, compliance regime and operator performance (including impact on subsistence fees), incident management.

It was noted that the current Environment Management System may be amended prior to commencement of waste operations on site.

No non-compliances were recorded during the inspection.

Please notify Natural Resources Wales when the site begins to accept and treat waste as it is likely we will conduct another inspection at that time.
