## 4. Details of our assessment

This was a routine review of data carried out by Malcolm Dines (Waste Regulation Officer) as part of planning for a compliance visit.

NOTE - This compliance report has been revised and re-issued as I incorrectly scored the breach as a category 3 and this is now revised to a category 4 breach as, despite the repeated failure to notify Natural Resources Wales and vary the permit to take into account changes of the registered office, it is not reasonably foreseeable that this breach would result in an impact on the environment.

### **Permit Breaches**

#### W4C - Notification - Cat 4; Permit Condition 4.3.4(a)

You have been given this category 4 breach under the above permit condition because you have failed to notify Natural Resources Wales of a change of the registered office address for Asgard Renewables Ltd.

Permit condition 4.3.4(a) requires you to notify Natural Resources Wales within 14 days when the registered office address has changed. According to the Companies House website, there have been two changes of registered office address this year and five in total dating back to 2017 and you have not notified Natural Resources Wales of any of them.

**Action:** Submit an administrative variation to change the registered office address on your permit, that is good enough to be duly made **by 17 November 2025**.

## Important information

### Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
