4. Details of our assessment

Natural Resources Wales (NRW) Waste Regulation Officer Mark O’GORMAN Waste Regulation Officer Cerys PHILLIPS attended Trehir HWRC, Pandy Lane, Llanbradach, Caerphilly, CF83 3RP at 12.50pm Tuesday 14th October 2025 on to conduct an unplanned site visit and inspection of Permit site EPR-LP3895FK . During the visit the weather conditions were dry and clear. At the time of the visit the site was open to the public and fully operational. NRW officers O’GORMAN and PHILLIPS met with a member of staff who showed NRW officers around the permitted area and explained operations and site procedures.

PERMIT INSPECTION

The site’s security was good with the fencing around the site and the site’s main gate in a good condition. All waste streams have separate, clearly signed storage containers. No waste storage containers were filled beyond capacity and the general housekeeping of the site was in good condition. The site’s main yard was free from large debris, litter and undamaged. Staff at the site regularly check if user’s waste is compliant and if it’s being disposed of in the correct way and were on hand to assist and advise customers when required. The staff operate a clean as you go method to keep litter and debris on the site to a minimum. The site presented no issues with drainage, with the site’s drains being free from debris and blockages. NRW officers did not witness any offensive odours or excessive noises during the site inspection or any issues with the sites drainage.
