The SIMEC Uskmouth Power permit includes condition 3.1.5:

'Periodic monitoring shall be carried out at least once every 5 years for groundwater and 10 years for soil, unless such monitoring is based on a systematic appraisal of the risk of contamination'.

NRW received a letter from SIMEC Uskmouth Power Ltd on 22nd October 2019 that detailed a request for the monitoring requirements be delayed.

On the basis that the power station has been non-operational since April 2017 and that there have been no recorded incidents that could have led to groundwater or soil contamination since the previous monitoring, then NRW agree to such a delay.

The revised date for the provision of monitoring data in respect of groundwater and soil is therefore 31/7/2021.
