4. Details of our assessment

This report details the site visit made on the 22nd of October 2025 to Berthgron Quarry Transfer Station, permit reference number EPR/UP3695FZ held by Valley Recycling Limited. Natural Resources Wales (NRW) Officers Carla CURTIS and Nicola ROSSITER attended the permitted facility at Ty Du Farm, Nelson for an announced routine site inspection. Officers arrived at around 12:00. The weather was dry, sunny and mild.

Officers met with site manager, Mr Lyn BOWEN, who showed officers around the facility. The visit consisted of an inspection of the permitted area and a discussion in the site office regarding waste returns and site management documents.

INSPECTION

The site was operational at the time of the inspection and was organised and appeared well managed. Incoming waste streams were clearly stored in individual bays or the appropriate skips after being sorted by plant machinery or by hand on site. It was noted that the site had been relatively quiet recently and Mr BOWEN advised that they no longer supply skips. No crushing equipment was active at the time of the inspection. However, Mr BOWEN clearly explained the management of crushing activities when operational. The several stockpiles of inert wastes awaiting crushing and stockpiles of processed aggregates were clearly segregated and contained minimal contamination. General housekeeping on site was of a good standard.

There was no excessive noise along with no airborne dust present during the site inspection. There were also no offensive odours witnessed by NRW Officers on site and security was of no concern.
