4. Details of our assessment

Thank you for your co-operation during the visit.

The site was visited on a particularly wet morning.

The following issues were noted during the inspection:

Filter bed mechanism

It was seen that the filter bed rotating arms weren't turning at the time of inspection, even though there was sufficient flow of sewage onto the bed.

Action: Please investigate this and repair as necessary.

Timescale: Please provide evidence that this issue has been sorted by 5/12/2025.

Effluent Sampling point

Permit condition 5 requires that there is an accessible means of taking effluent samples.

It was seen that the outfall to the river was inaccessible due to high fences etc. The alternative would be to take a sample at the final effluent tank, however this was covered by a grill which meant a sample could not be taken.

Action: Please provide a location where a representative sample can be taken.

Timescale: Please sort by 5/12/2025, or provide a timescale to sort it.
