4. Details of our assessment

On the 24th of October NRW received sample results from the permit holders, who had commissioned independent sampling. The results are as follows:

BOD

Permitted limit of 40 mg/l

Sample result of 6 mg/l

Suspended Solids:

Permitted limit of 50 mg/l.

Sample result of 223 mg/l

The results show a permit exceedance for suspended solids. It is however noted by the analyst:

'This sample has been analysed for Total Suspended Solids outside recommended stability times. It is therefore possible that the results provided may be compromised'

Therefore the analyst has advised that the result may be incorrect, and additional investigation is required.

Action required by dates specified:

- **Contact the sampling company to query the analyst comments and investigate the cause of suspended solid increase. Detail what measures have been taken to rectify the problem. Complete by 19/12/2025**
