### 4. Details of our assessment

A routine sample taken on 23 September 2025 returned a suspended solids result of 78.5 mg/l against a permit limit of 60 mg/l.

During the telephone conversation of 8 October 2025. The centre manager indicated a de sludge of the system had been carried out in the week prior to the 7 October 2025.

The operator undertakes their own sampling programme, with the most recent samples taken and sent for analysis on or around the 29 September 2025.

Please confirm the system is running appropriately, in good working order and within compliance by 21 November 2025

Email received from the Operator 27 October 2025.

*The results have been returned from Decus for the sample taken on the 29<sup>th</sup> September 2025. The results are showing a level of 54.0 for the suspended solids. I will be taking another sample this week to check again for the levels to ensure they are below our allowed reads.*

*As I said during our conversation, we also had a full tank empty and desludge on the 3<sup>rd</sup> October 2025. I am confident that the next results will be within the limits allowed.*
