4. Details of our assessment

An audit and site inspection was carried out at Lower Mulsford Poultry Farm on 28th October 2025. Paperwork was produced to show compliance with all of the compliance criteria listed above. A high level of compliance with the permit was evidenced.

Stocking rates on the farm have been reduced in line with the RSPCA welfare standards.

Energy efficiency and water usage is being well recorded and documented on farm.

Action: A four-year review of usage of these, waste, and raw materials should be completed and submitted to your NRW Environment Officer following the end of the 2025-26 year.

Home grown wheat is incorporated with the bought-in feed as the birds get bigger.

Action: please provide information / calculations to show that the addition of wheat into the diet does not negatively impact with the requirement for phosphorus and Nitrogen to be reduced throughout the birds' lifecycle.

The manure is used by DJ Huxley (Farms) Ltd for its agricultural benefit and is taken off-site for storage. This is being recorded in the farm's nutrient management plans, which were made available for inspection.

The on-farm incinerator is not currently being used. The deadstock is stored securely, for regular pick-up by a fallen stock firm based in Whitchurch.
